

E-learning Platforms

The university uses three E-learning Platforms:

Microsoft Teams:

A platform for attending interactive lectures online, and communication with your colleagues and staff members.

Moodle:

An e-learning a platform that contains the course material that you will study and allows you to communicate with the course instructor, as well as taking exams and submitting assignments.

(Moodle is used for the courses of Faculties of Architecture and Design, Information Technology, Pharmacy and Medical Sciences, Arts and Sciences, Law, and Media)

Blackboard:

An e-learning platform that contains the course material that you will study and allows you to communicate with the course instructor, as well as taking exams and submitting assignments.

Blackboard is used for the courses of the Faculty of Administrative and Financial Sciences, and the Faculty of Engineering

E-Services

The university provides other e-services:

Edugate

A system that provides students with e-services such as: Online Admission Application, online courses registration, view the semester courses Schedule, view Academic Plans for majors, view academic and financial data (marks, penalties...etc.), and view Academic Calendar.

Microsoft Office 365

Each student receives immediately an account on Microsoft Office 365 cloud. It provides the students with the following advantages:

- Student Email: this is the official students email which will be used for communication.
- One Drive: a cloud-based storage of student access
- Cloud based office suite: including Word, Excel, Power point, ..etc.
- SharePoint: a space to create your own website
- And many more applications provided from Microsoft 365 account.

Technology Requirements

- In order to access the e-learning platforms it is preferable to use a computer with Internet access with the following software:
 - Internet browser: Google Chrome (version 88 or above)
- The student may use Mobile smart phone to access some platforms, but the limitations of views and functionality makes this option not favorable during exams.
- It is recommended to setup Moodle, MS teams and your email account on your smart phone to receive notifications and for quick access to your classes (as explained in the training videos).
- The student must make sure that the device used for learning is ready and suitable for interactive learning in terms of clarity of sound and picture.
- The student must ensure the adequacy of the Internet package during learning.
- In case there are other applications or requirements that are necessary in some courses, the student responsibility is to know these requirements listed in the course syllabus and to obtain them.
- The student must make sure that he/she can access and use learning platforms, and to solve any technical problems before the start of the teaching.

- Attendance in Courses is mandatory. Students must attend the virtual/ face-to-face classes according to the scheduled time of the course. Attendance will be tracked through the online learning management systems by the faculty.
- Attendance will incorporate completion of course requirements, participation in completing course assignments and interactions with faculty. Should it be determined that the student is not meeting attendance policy requirements, university attendance regulations will be enforced. Also, the student must abide by rules and regulations set by the teacher during attending these classes.
- It is the student's responsibility to view the course syllabus and to know all the details of the course including: coursework, exams, or special instructions or requirements of the course.
- It is the student's responsibility to follow up with the course announcements, faculty announcements, and university announcements through all the official platform, websites, and learning management systems.
- Access passwords may not be shared or given to anyone other than the user to whom they were assigned to for any reason. All users of the UOP systems are responsible for maintaining the security of usernames, passwords and any other access credentials assigned.
- Users are responsible for any and all uses of their account.
- Failure to read UOP policies, guidelines, requirements and regulations will not exempt users from responsibility.
